      - i. Report given by Brian Barakat. Task force aims to have completed draft submitted to EC by evote in the next few weeks.

- 9. Rules of Civil Procedure Task Force Update
  - a. David Hazouri and Judge Artigliere gave update concerning the proposed changes to the Rules of Civil Procedure. The goal of the task force is to have the proposed changes finalized this fall so that they can be proposed to the Rules Committee at the Winter Meeting. The review of the proposed rule changes will be analyzed by the members of the Legislative Subcommittee.

## 10. Amicus Brief Updated –

a. Dineen Wasylik gave the update. The task force on amicus briefs is working to put together formal guidelines concerning amicus briefs. There was a request for an amicus brief by a member in the last month. There was analysis and ultimately a denial of the invitation for the section to submit an amicus brief. The formal guidelines will express the sentiment that amicus briefs should be submitted rarely and in cases where a court specifically requests one or if the issue is one of great importance to the section – with the idea that the Section should not be submitting amicus unless there is consensus as to the importance of the issue and consensus of the position of the section. Goal is to not meddle but weigh in on individual cases. The formal guidelines will also include a procedural framework and timeline for responding to such requests in the future. Finally, the website now has posted all amicus briefs that have been submitted by the Section in the past.
