## 6. Committee Management - Roles of Officers:

*Chair*: The Chair serves as the main point of contact for the CLE Committee with third parties and coordinates all communication with other BLS Committees and BLS leadership. The Chair is responsible for scheduling officer and committee meetings, communicating as appropriate with all committee members between meetings, and ensuring that all appropriate matters come before the committee at such meetings. The Chair is also responsible for coordinating the CLE Committee's efforts with respect to publishing articles in the Florida Bar Journal. The Chair shall represent the Committee at all BLS Executive Council meetings or arrange for a substitute representative.

*Vice-Chair*: The Vice-Chair will assist the Chair in fulfilling his or her responsibilities. Additionally, the Vice-Chair is responsible for encouraging and coordinating participation in CLE Committee meetings, taking minutes of all meetings, and drafting a written report to the Executive Counsel summarizing the CLE Committee meetings. Where practicable, the Vice-Chair will serve as the Chair at any meeting in which the Chair is absent.

**Second Vice-Chair** / **Judicial Chair**: The Second Vice-Chair and Judicial Chair serve at their and the CLE Committee's respective discretion and to the extent such officers volunteer for substantive or procedural projects of the CLE Committee.
