An act relating to value of motor vehicles exempt from legal process; amending s. 222.25, F.S.; revising upward the value of a motor vehicle owned by a natural person that is exempt from legal process; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

- Section 1. Subsection (1) of section 222.25, Florida Statutes, is amended to read:
- 222.25 Other individual property of natural persons exempt from legal process.—The following property is exempt from attachment, garnishment, or other legal process:
- (1) A debtor's interest, not to exceed \$5,000 \$1,000 in value, in a single motor vehicle as defined in s. 320.01.

Section 2. This act shall take effect July 1, 2022.
