Chapter 713.78 to clarify that (1) storage liens on motor vehicles and vessels can be foreclosed only under the procedures set out in Fla. Stat. 713.78 and 559.917; (2) the same procedures for a lender or owner of a vehicle or vessel to request an inspection related to a towing and storage liens is the same as set out in 713.585 for a repair lien are also applicable to towing and storage liens for vehicles and vessels under Fla. Stat. 713.78; (3) the same procedures for posting a bond regarding repairs on vehicles and vessels in 713.585 and 559.917 are also applicable to towing and storage liens for vehicles and vessels under Fla. Stat. 713.78.

The proposed Triple Motion for the Protected Series LLC additions to the LLC Act is below:

The following triple motion was made by Louis T. M. Conti, seconded by [to come].

RESOLVED, that the Florida Bar Business Law Section (the "Section") supports proposed legislation adding Protected Series Limited Liability Company provisions to the Florida Revised Limited Liability Company Act, Chapter 605 (the "Florida LLC Act"), by adding new Sections 605.12101 through 605.12803, Florida Statutes, with respect to the creation of Florida Protected Series Limited Liability Companies, and for rules addressing the registration and requirements for foreign Series

Limited Liability Companies doing business in Florida. The proposed new sections being added to the Florida LLC Act are based on the Uniform Protected Series Act promulgated and adopted by the Uniform Law Commission. The form of the proposed Protected Series LLC provisions are substantially in the form of the draft legislation, draft dated as of August 31, 2022, as presented to the Executive Council of the Section, and subject to such further changes as are deemed appropriate and approved by (i) the Protected Series Limited Liability Company Task Force, and (ii) the Executive Committee of the Section; and it is further

RESOLVED, that the Proposed Legislation: (1) Is within the Section's subject matter jurisdiction as described in the Section's bylaws; (2) Either is beyond the scope of the bar's permissible legislative or political activity, or is within the bar's permissible scope of legislative or political activity and the proposed Section position is consistent with an official bar position on that issue; and (3) Does not have the potential for deep philosophical or emotional division among a substantial segment of the bar's membership.

Purpose is to review §501.207 of FDUTPA and the holding in *Perlman v. PNC Bank, N.A.*, 38 F.4th 899, 905 (11th Cir. 2022). Recently, the Eleventh Circuit in *Perlman* held that Fla. Stat. § 501.207(3) (FDUTPA) does not overcome the requirement set forth in *Isaiah v. JPMorgan Chase Bank*, 960 F.3d 1296, 1308 (11th Cir. 2020), that a receiver must allege the presence of at least one innocent director or stockholder to have standing to bring his aiding and abetting claims against a defendant. The Eleventh Circuit notes that while the statute might provide that the wrongful acts of the Receivership Entities are not imputed to Perlman, this does not change the fact that absent an allegation of an innocent director or stockholder, the Receivership Entities cannot be said to have suffered an injury for purposes of common law tort claims against third parties.
