KM - Track via pledge?

CS – finds access to stats, reads from website

Recent decline in participation, but actual hours went up by 10%

KM: consider benchmarking our percentages against the bar at large, or just against ourselves (BLS) historically?

JF: can we separate out by practice? (CS: no, b/c the self-reporting form for TFB doesn't require it.)

Want to track numbers so we can create concept of "challenges" (BLS vs "Reptiles", for instance)

LI: want people to feel more engaged. Have tasks with timelines, not just ad hoc.

TT: suggest "Outreach" pipeline, set up as a subcommittee

LI: Pro Bono week, Membership, Publications (pro bono stories), Pro bono award

SH: we have some outreach programs already via legal services, have a need for volunteer staffing. Have projects that we might be able to steer you towards.

LI: have liason on this committee would be a good idea. (discussion re either SH or KD or both being liaison)

Can tie this to "outreach" idea

JM: clinics have not happened in Jax within past 3-4 years, not sure if they are still happening elsewhere. Might need to revive

Consider "Pro Bono Oppoprtunity of the Month" on website?

TT: suggest using email blast instead of passive website

ZS: social media? (everyone agrees great idea, TE says easy to do, everything in email also goes to social media)
