V. Approval of Minutes from June 22, 2023, Executive Council Meeting

The minutes for the June 22, 2023 meeting and are attached as **Exhibit 2** to the agenda. A motion to approve the minutes was made by Dineen Wasylik, and seconded by Brian Barakat. There was no discussion, and motion carried unanimously.

VI. Treasurer's Report

Treasurer Stephanie Lieb provided her Report (Exhibit 3 Recent Financials and Exhibit 4 Reimbursement Policy to the agenda). A motion to approve the financial report was made by Stephanie Lieb and seconded by Allison Leonard. Following a discussion, the report was unanimously approved.

VII. Triple Motions

Will Blair, Prof. Cohn, and Greg Yadley addressed the need to update Chapter 517 and the policy considerations which underly proposed changes.

Will Blair then moved the Council to approve the following:

a. Chapter 517 Task Force (Exhibit 5 – Draft Bill and White Paper)

RESOLVED, that the Florida Bar Business Law Section (the "Section") supports proposed legislation updating and modernizing Chapter 517 of the Florida Statutes – The Florida Securities and Investor Protection Act (the "Proposed Legislation"), substantially in the form of the draft legislation, dated as of August 4, 2023, presented to the Executive Council of the Section, and subject to such further changes as are deemed appropriate and approved by the Chapter 517 Task Force and the Executive Council of the Section; and it is further

RESOLVED, that the Proposed Legislation: (1) Is within the Section's subject matter jurisdiction as described in the Section's bylaws; (2) Either is beyond the scope of the bar's permissible legislative or political activity, or is within the bar's permissible scope of legislative or political activity and the proposed Section position is consistent with an official bar position on that issue; and (3) Does not have the potential for deep philosophical or emotional division among a substantial segment of the bar's membership.

The motion was seconded by Judge LaRose. Following a vote, the motion was approved. The judges and government employees abstained.

Phil Bates provided the following report and moved the Council to approve the following:

b. Chapter 607 Subcommittee (Exhibit 6 – Draft Bill and White Paper)

RESOLVED, that the Florida Bar Business Law Section (the "Section") supports proposed legislation addressing changes and updates to Chapter 607, Florida Statutes, the Florida Business Corporations Act, primarily including the addition of provisions addressing ratification of defective corporate actions and overissuances of securities, substantially in the form of the draft legislation, draft current draft as presented to the Executive Council of the Section, and subject to such further changes as are deemed appropriate and approved by (i) the Chapter 607 Subcommittee, and (ii) the Executive Committee of the Section; and it is further

RESOLVED, that the Proposed Legislation: (1) is within the Section's subject matter jurisdiction as described in the Section's bylaws; (2) either is beyond the

scope of the bar's permissible legislative or political activity, or is within the bar's permissible scope of legislative or political activity and the proposed Section position is consistent with an official bar position on that issue; and (3) does not have the potential for deep philosophical or emotional division among a substantial segment of the bar's membership.

Andrew Schwartz seconded the motion. The motion was approved. The judges and government employees abstained.

VIII. Reports of Substantive Law Committees

Chair Stein requested that a how-to playbook be prepared by each committee and that each committee designate a liaison to IMF, CLE, and Pro Bono committees.

A. Bankruptcy/UCC – Kenneth Murena, Chair; Adina Pollan, Vice Chair; Matt Hale, Second Vice Chair; Honorable Mindy Mora, Judicial Chair; Prof. Jeffrey Davis, Academic Chair

Ken Murena reported the following:

The Bankruptcy/UCC Committee met at 9:00 a.m. on Saturday, September 1, 2023. The meeting began with introductions by Chair Murena and approval of the minutes from the prior meeting at the Annual Meeting in June. Vice Chair Pollan then updated the Committee on the legislative review subcommittee and its review of recent proposed legislation from RPPTLS. Members of the Committee discussed the status of various legislative initiatives. For 2024, the Committee will again seek to pass the Warehouse Lien Amendments and Judgment Lien Amendments approved by the Executive Council. The Committee is also looking for a sponsor and a vehicle to bring the FDUTPA amendment approved by the Executive Council before the Legislature.

The Committee has several legislative initiatives it is working on and monitoring with an eye towards 2025, including Article 12 and UCRERA. The Committee has 5 active Study Groups. One Study Group is analyzing avenues to fix Florida's Secured Transactions Registry in response to a recent Eleventh Circuit case. Another Study Group is reviewing a recently passed Commercial Financing Disclosure law to decide if a glitch bill may be needed. A Study Group was recently formed to review the report and work product prepared by the Article 12 Task Force and the impact of the amendments to the rest of the UCC necessary to incorporate new Article 12. And, the ABC glitch bill study group is remaining intact to review a potentially forthcoming uniform ABC Act. Finally, the Committee's Motor Vehicle Exemption Study Group continues to consider proposed legislation to change the exemption limit.

The Committee is also monitoring various State and Federal legislation that touch on issues relevant to the Committee.

The Committee heard reports from liaisons to other BLS Committees, the local bankruptcy bar associations across the State, and liaisons to other organizations. Highlights include updates from John Hutton on Financial Literacy programs and a report from Bob Charbonneau regarding the Commercial Law League of America regarding, among other things, the status of making permanent the Subchapter V debt limits and lobbying efforts after which a lively discussion ensued.

The Committee promoted upcoming CLE programs of this Committee, including the Judge Michael G. Williamson View from the Bench in November 2023, and other Committees of the Section, and appointed a liaison to the CLE Committee.

The meeting concluded with a CLE program on Litigating Confirmation Issues in Subchapter V Bankruptcy Cases, sponsored by Shuker & Dorris, P.A., featuring Judge Roberta Ann Colton, Megan W. Murray, and Amy Denton Mayer, and moderated by R. Scott Shuker.

Study Groups - 5 Active:

UCC Article 9 - Formed following the 11th Circuit decision in the case In re NRP Lease Holdings, LLC, 50 F.4th 979 (11th Cir. 2022) which held that under Florida law, because the Florida Secured Transaction Registry did not employ "standard search logic" for searches of financing statements. In answering the 11th Circuit's certified questions, the Florida Supreme Court in 1944 *Beach Boulevard*, *LLC v. Live Oak Banking Co.*, 346 So.3d 587, 593 (Fla. 2022) adopted "the definition of 'standard search logic' accepted in the secured transactions industry.

Commercial Financing Disclosure Law - Product Brokers & Providers - Study group is looking at this new law (passed this year) and what is happening with Revenue Based Financing in Florida and nationwide and is preparing a position paper regarding a possible legislative proposal to address definition of "business," "business purpose transaction," "accounts receivable purchase transaction," the Attorney General as the "exclusive" authority to enforce legislation.

UCC Article 12 - formed to study issues identified in proposed Amendments regarding certain terminology used, and how it cross-references and affects other Florida Statutes

Motor Vehicle Exemption Study Group

CLE - Litigating Confirmation Issues in Subchapter V Bankruptcy Cases:

Produced by Mariane Dorris and Scot Shuker with a terrific panel featuring Judge Colton, Meagan Murray, Amy Denton Mayer, and Scott Shuker as the moderator - The program examined the most commonly litigated confirmation issues in a Subchapter V Bankruptcy Case with a focus on evidence needed to support or oppose confirmation.

B. Blockchain & Digital Assets Committee – Daniel Maland, Chair; Robert Kain, Vice Chair; Terry Sanks, Second Vice Chair; Honorable Lisa Munyon, Judicial Chair; Prof. Zachary Catanzaro, Academic Chair

Robert Kain reported the following:

The Blockchain and Digital Assets ("BDA") Committee met on September 2, 2023, and engaged a discussion as to numerous topics.

Article 12: The BDA Committee was given a report on the UCC Article 12 legislative effort. The ULC proposed Article 12 establishes a basic framework creditors to perfect their security interests in the debtor's digital assets with via a controllable electronic record, or CER. In addition to new Art. 12 (proposed F.S. 669), the ULC (Uniform Law Commission) has revised Article 9, secured transactions, to mirror Art. 12's CER framework. Several members of the BDA Committee are Art. 12 Task Force members. F.S. 669 (Art. 12 + 9) is 120 pages but lacks a legislative sponsor. Materials available on the BLS website. The Art. 12 Whitepaper is nearly complete.

CLE: The BDA committee co-sponsored a two-hour Art. 12 CLE at the annual meeting.

Liaisons: Zev Chesal accepted the liaison position to the Pro Bono Committee, Donna Rinck accepted the liaison position to the CLE Committee and Woody Pollack accepted the liaison position to the Legislative Committee. Additional liaisons are needed for the IMF and the Communications Committees.

Case Law Update: *Ripple v. SEC*. The SDNY recently ruled that the cryptocurrency RIPPLE coin XRP was not a security because the coin was sold on an exchange to buyers who had no information about the sellers (a blind bid/ask) and there was no expectation of profit based on the efforts of others (the Howey in the Hills test). The SEC is seeking an interlocutory appeal on the issue. The Judge did find that written agreements between Ripple and institutional investors were securities. (Pooling agreements). Ripple also had deals with employees and service providers where they would be paid with tokens (employee compensation). Judge found employee compensation was not a security. Ripple made no commitments that they would actively promote the coin. The Court found that as to employee compensation there was no expectation of profit based on the efforts of others.

Federal Regulation: Fed offered additional regulatory guidance to state regulated banks. Novel uses of technology require vigilance.

Future of Blockchain: Potential other use cases: (1) Alex: cross border real estate transactions. Timeshares can track fractionalizing interests in real property.

Winter CLE: Florida Blockchain Association. Specialized courts: Delaware continues to operate focused on Delaware corporate law. Florida deserves a court that specializes in highly technical fields. Texas is trying to back crypto with gold/silver.

C. Business Litigation – Brian Barakat, Chair; Joe Van de Bogart, Vice Chair; Utibe Ikpe, Second Vice Chair; Honorable Edward LaRose, Judicial Chair (State); Honorable Darrin Gayles, Judicial Chair (Federal)

Brian Barakat reported the following:

Legislative Update

1. Came off without a hitch. Thank you to Manny Farach, Aimee Diaz Lyons and Calbrail Banner for putting in the heavy lifting on this class. It went very well. We are fortunate to have the participation of Secretary Byrd and Senator Martin.

Change in the Number of Judicial Circuit's.

- 1. I have provided the website and the publicly available material in the Biz Lit agenda, I'll make sure they get to Peter for the minutes of this meeting.
 - a. https://www.flcourts.gov/Administration-Funding/Court-Councils-Commissions-and-Committees/Judicial-Circuit-Assessment-Committee
- 2. This was spearheaded by Paul Renner, the Speaker of the House.
 - a. Ostensibly the group was proposed to create efficiencies by consolidating smaller circuits.
- 3. This was discussed by Lisa Walsh at Lunch and briefly by our committee. I had a meeting with Carlos Martin the Public defender from the 11th Judicial circuit.
- 4. It is clear that this is in the nature of a political action, but the function of it is unclear.
- 5. There have been several comments against the idea. No independent comments have come out in favor of the proposal. Most of them say that Florida in fact has comparatively few judicial circuits, comparatively few elected prosecutors, particularly when evaluated in terms of population.
- 6. While I don't think there's any world where the Circuits are consolidated, the rule empowers the studying body to reduce or increase the number of circuits. I suspect there's a greater likelihood of the group recommending to break up the metropolitan areas into multiple circuits than consolidating the small circuits.
- 7. So, we will monitor this issue as it moves forward and report back in the summer.

Restrictive Covenants

There are two further amendments to the restrictive covenants statute proposed to limit the applicability of restrictive covenants to physicians. There have been comments that this should not apply in the context of the sale of a business. The committee will meet to develop a comment.

Private Judges

After Biz Lit Retired Judge Fine met with me and suggested that he wanted to provide a rewrite of the private judge statute, which I understand from Mr. Polenberg has been attempted without success in the past. Judge Fine's proposition is that the statute does not provide procedure and direction to the existing state framework to work with Private Judges. I understand that to be precisely where it blew up the last time. So, it's fair to say there is a need, if

not a will. So, I've proposed a study group to evaluate if this is legislation we want to support. Allison Leonard has already agreed to be on, not lead, but be on the committee. So, if you want to be on a committee that Alison is not yet leading, this is your chance.

D. Computer Law & Technology – Talia Boiangin, Chair; Michael Bittner, Vice Chair; Andrica Jasmaine Alexander, Second Vice Chair; Honorable Julie Sneed, Judicial Chair; Prof. Vincenc Feliu, Academic Chair

Talia Boiangin reported the following:

The committee approved its minutes, review and update on the activities of the last legislative Session, received a blockchain law update, discussed hot topics, including privacy and AI, discussed, USPTO policies regarding works generated by AI, received and update from Judicial Chair Judge Sneed regarding AI concerns, and received a CLE presented by Michael Bittner and Andrica Alexander regarding Consumer and Employee Rights.

E. Corporations, Securities & Financial Services – Toni Tsvetanova, Chair; Vice Chair; Valeria Angelucci; Kelly Roberts, Second Vice-Chair; Prof. Stuart Cohn, Academic Chair

Toni Tsvetanoa reported the following:

The Corporations, Securities & Financial Services Committee (CSFS) had a productive and well-attended meeting (over 60 attendees). The following actions took place.

CSFS discussed the proposed legislation by the Series LLC Task Force, the Chapter 517 Task Force and the Chapter 607 Subcommittee. There were no questions in connection with the materials circulated. The Chapter 517 Task Force and the Chapter 607 Subcommittee triple motions in connection with such proposed legislation were unanimously approved by the CSFS.

Chapter 617 Task Force provided an update on its progress to date, which continues at a steady pace.

The Opinion Standards Committee plans to meet virtually after the ABA Opinions Committee meets in September after the Labor Day Retreat.

CSFS was addressed by Judge Mora and Robert Kain in connection with the proposed legislation by the UCC Article 12 Task Force. CSFS may be interested in some of the work being done by the task force and might consider a study group to look into certain of the proposed revisions. Robert Brighton, who is already involved with the UCC Article 12 Task Force, expressed interest and will follow up on next steps.

CSFS discussed a number of potential CLEs that the committee will be exploring further.

It was noted that the RPPTL Section is proposing revisions to the Florida Uniform Disposition of Community Property Rights at Death Act and that materials were circulated for CSFS review.

The January and June meeting minutes of the CSFS were approved.

Kaufman Rossin presented an engaging CLE on the following topic: "Updates from a forensic accountant & valuation perspective: the Surfside building collapse & others." - February 15 and 16, 2024 – Federal Securities CLE

Avery Chapman reported the following:

- 1. Avery has been on the Working Group of the new Rule Committee to draft a Comment from BLS to the CPRC's proposed rules. Avery integrated EDDEC's proportionality concerns into the drafting of the Comment.
- 2. The Committee did also pass a motion supporting the Rules of Court Working Group's draft Comment to the CPRC's proposed rules containing changes to the Civil Rules.
- 3. This was a follow-up, planning meeting to our June 2023 meeting at The Florida Bar Convention, where we also presented our 4 hours CLE.
- 4. The plan is to present several CJEs to judges of various circuits, as well as presenting the CLE we provide each annual Bar Convention. We are currently formulating the curriculum for the CLE and, for the CJE, as well as a Bench Book handout for the judges regarding electronic discovery and digital evidence.

Darren Spielman reported the following:

The committee is full steam ahead on planning for the IP Symposium, which is formally scheduled for April 11-12, 2024 at the JW Marriot in Orlando. The committee's Board Certification Study Materials Task Force further advancing the creation of a study guide for the IP certification exam. There are currently 133 IP Board Certified Attorneys. The Committee's Florida Trademark Statute Task Force is pushing forward with potential new Statute Proposal to amend the Florida Trademark Statute which may be ready for a triple motion by next summer. The committee reviewed and discussed recent law.

F. Chapter 48 Task Force - Giacomo Bossa and Jim Murphy, Co-Chairs

Jim Murphy reported that the Task Force had a productive and well-attended meeting on Friday, September 1. Most of the members attended the meeting virtually by Zoom. The Task Force continued its discussion about possible amendments to sections 48.161 and 48.181, Florida Statutes, that address substituted service on the Florida Secretary of State and began consideration of proposals by the Florida Association of Process Servers (FAPPS) to further amend various other provisions of Chapter 48. Toni Tvestenova reported the following:

Chapter 617 Task Force met on Friday. There were over 25 attendees. Several scholars joined the meeting as well. The members present introduced themselves. The Task Force then continued with the report of one of its subgroups that is reviewing proposed revisions to the dissolution provisions of Chapter 617. The Task Force continues to make good progress, meets approximately every two weeks, and aims to be able to present proposed legislation for the 2025 legislative session.

April Stone reported the following:

Our meeting was well attended. We discussed getting the Fellows more involved with writing articles and blogs. We discussed content for the October newsletter. October is Pro Bono month. In accordance with the June 2023 approved triple motion, the Committee proposed the following triple motion:

Proposed triple motion for the Committee to file a comment to the Florida Bar's Civil Procedure Rules Committee's proposed revisions to the Florida Rules of Civil Procedure in response to the Florida Supreme Court's request for comments substantively similar to the draft comment circulated to the executive council, including comments consistent with provisions previously approved and taken by the Section, including those regarding proportionality and the scope of discovery.

Resolved, that the comment: (1) is within the Business Law Section's subject matter jurisdiction as described in the Section's bylaws; (2) is within the bar's permissible legislative or political activity and the proposed Section position is not inconsistent with any official bar position on that issue; and (3) does not have the potential for deep philosophical or emotional division among a substantive segment of the bar's membership.

The motion made by Russell Landy. The motion was seconded by Avery Chapman. Thereafter a discussion was held. They motion was approved unanimously. The Judges and government employees abstained.
