- c. <u>Small Business Clinics</u> Judge Isicoff, chair
  - Some small business clinics will be highlighted at ABA April meeting (can advertise there)
- d. Pro Bono Award Kathy McLeroy and John McDonald, co-chairs
  - i. Nominations due January 31, 2024
    - No nominations but we have hold over nominations from last year
    - 2. 5 page maximum
  - ii. Review of nominations strategy
  - iii. Up and comers recognition?
    - Look to liaisons to provide nominations from the other various subcommittees/liaisons can reach out to committee chairs
  - iv. Law Firm recognition? What criteria if we recognize a law firm?

- 1. Recognize law firms that support their up and comers that pursue pro bono (i.e. firms that require pro bono hours)
  - a. May be an issue of pitting bigger law firms against smaller firms with less resources
  - b. Possible solution: tier the awards based on small, mid, or large firms
- 2. Send a blast/questionnaire to firms to see what they are doing to promote pro bono
- 3. Florida supreme court recognizes law firms (jan 18 award ceremony)
  - a. We can figure out what their criteria is so that we can use it to determine which law firms to recognize
- 4. Ask EC if they would support the committee looking at up and comer or law firm awards
  - Minor budget impact based on what award we would give

#### e. Pro Bono Week – Held in October 2023

- Mark Stein and Peter Valori sent a video for pro bono week asking attorneys to take a pro bono case
  - 1. Website only shows videos from Judges Williamson, Colton and Isicoff
  - 2. Make sure videos are updated for pro bono week next year
- f. Membership Chair needed
  - i. <u>Purpose</u>: identify different people from different constituencies (i.e. groups outside of the Florida Bar)
  - ii. Could possibly fold this into the Outreach Committee
